According to Sections 19 (1) (g), 21 & 41 of the Constitution of India, the Government of Tamil Nadu shall immediately withdraw the order issued by the Government and the Public Service Commission and take disciplinary action against the Government Authorities who have violated the Human Rights.

Dear Sir/Madam,

- 1. No one can deny the basic rights guaranteed in Article 19 (1) of the Constitution of India.
- 2. According to Article 21 of the Constitution of India, no person shall be deprived of life or liberty except as established by law.
- 3. Article 41 of the Constitution of India, insists Government to protect individual's Right to Work
- 4. The Constitution of India insists on the continuous compliance of the officers according to the provisions of the Constitution, in accordance with Article 375.
- 5. According to Section 6 of the Vaccination Act, 1880, the person who has been vaccinated should not be allowed to enter the town for 40 days due to the possibility of spreading the virus to his/her neighbor.
- 6. In email to the Chief Secretary of TamilNadu and the Health Secretary dated 25.05.2021, we asked explanation citing the violation of the Constitution of India and Basic Human Rights by the Chennai City Corporation Commissioner through a public announcement on NEWS18 Tamil Channel which says "People who involve in distribution of vegetables should get vaccinated mandatorily"
- 7. GO (Ms) No.391 dated 29.05.2021 and GO (Ms) No.394 dated 05.06.2021 dated Government Order No. XXV say "Industries which have been permitted to operate shall initiate immediate action to vaccinate all their employees within a month's time". That was very shocking.

These orders force the employers to make arrangements to vaccinate all employees immediately within 30 days, and it indirectly cites that all employees should get vaccinated mandatorily. It also implies that employees who are not vaccinated will not be hired. An e-mail was sent on 03.06.2021 to the Governor, the Chief Minister and the Secretary to the Government of Tamil Nadu confirming the return of this illegal order in violation of the Constitution of India and the Basic Human Rights. But we didn't receive any reply till date.

- 8. In an e-mail dated 05.06.2021, sent to the District Collector of Salem, with a copy marked to you, we highlighted that Policemen used Healthcare workers and mandated the Covid testing on people who come out to public places during lockdown, and complained against the public servants and government authorities who have violated human rights and abused their power and are subjected to appropriate criminal actions.
- 9. On 04.06.2021, the Chennai City Corporation Commissioner Gagandeep Singh Bedi issued a statement to the media stating, "Those who have not been vaccinated in the next 10 days will not be allowed to enter Koyambedu market"

10. In the letter No. 2498 / E4 / 2020 issued by the Chief Education officer of Tiruvallur District on 04.06.2021, he said "Teaching and non-teaching staff who are employed by Government / Government aided schools in the administration of Tiruvallur should get vaccinated mandatorily against covid before 20.06.2021".

As per Dinathanthi's news dated 05.06.2021, the Chief Education Officers of Chennai and district of Tiruvallur mandated all staff who work under the department to get vaccinated before 20.06.2021

- 11. Vikatan online news dated 13.04.2021 says "Vaccination is mandatory for people who are above 45-years of age, should get vaccination mandatorily before 16th day of this month. The District Collector of Vellore, Mr. Shanmuga Sundaram has warned that the industries, shops, commercial entities who don't comply to this order will be sealed." <u>https://www.vikatan.com/news/tamilnadu/vellore-collector-orders-mandatory-coronavaccination-for-those-over-age-of-45-years</u>
- 12. On 16.04.2021, The Ministry of Health and Family Welfare replied to Mr. Tarun's RTI MOHFW/R/E/21/01536 petition saying that "Vaccination for COVID-19 is voluntary".
- 13. On 23.03.2021, The Ministry of Health and Family Welfare replied to Mr. Dinesh's RTI File No.A.60011/06/2020-CVAC, saying that "As far as compensations is concerned, the COVID-19 vaccine being voluntary, there is no provision for compensation as of now "
- 14. On 09.06.2021, AIIMS replied to Mr. Manindra Kumar's petition RTI AIIMS/BPL/RTI/HOSP/2021/206, stating that "RT-PCR / Rapid antigen testing is not mandatory for everyone in India. It is voluntary. Please refer to Covid-19 testing FAQs on https://www.mohfw.gov.in for further detail."

- 15. The FAQ, provided by the Ministry of Health and Family Welfare, frequently states, "Only wear a mask if you are ill with COVID-19 symptoms (especially coughing) or looking after someone who may have COVID-19. Disposable face mask can only be used once. If you are not ill or looking after someone who is ill then you are wasting a mask" and "The following measures ARE NOT effective against COVID-2019 and can be harmful: WEARING MULTIPLE MASKS".
- 16. On 09.06.2021, tamil.oneindia.com posted a news on its website, "A study by the AIIMS and the National Center for Disease Control has revealed that Delta Virus, which was first detected in India, is able to infect the people who been vaccinated with Covishield and Covaxin Vaccines. The operation was performed on 63 patients admitted to the emergency department of AIIMS Hospital. 53 of them were vaccinated against either the Covishield or the Covaxin and 36 of them were vaccinated with both doses. That is, 76.9% of those who took one dose of the vaccine are infected with the virus, and 60% of those who took both doses are also infected with the virus."

- 17. Dinakaran online News dated 01.06.2021 says "Mr. Anandiah who belogs to Nellore District of Andhra Pradesh, invented ayurvedic herbal medicines (that uses traditional ayurveda ingredients such as Kandankathirikkai, Erukkampoo, Wolmilaku, Thippili, Turmeric) to cure covid, and this has been approved by Ministry of Ayush. According to the Ministry, all his covid medicines are approved, other than the eye drop for Oxygen deficit patients for which result will be announced in a couple of weeks" <u>https://www.dinakaran.com/News Detail.asp?Nid=680772</u>
- 18. The Government of Tamil Nadu, Government Authorities and Public Servants , who force the mask, covid testing and vaccines both directly and indirectly, are subjected to
 - a. Violation of Sections 19 (1) (g), 21 & 41 of the Constitution of India
 - b. Human rights abuses and violations
 - c. Violation of guidelines provided by the Ministry of Health and Family Welfare
- 19. The media, government officials and popular faces of public have been campaigning that the vaccine is the only weapon to protect the population from the Covid and that the vaccine would not bring any side/adverse effects. Such campaigns are not acceptable in any situation where the vaccine manufacturer is not responsible for the damage caused by the vaccine and is not liable to pay compensation.
- 20. The media is constantly spreading anxiety and fear among people, through various programmes and news programmes, by displaying the SCORE BOARD of Covid infected counts and Covid deaths counts.

Based on these statements and evidences, I am requesting you to issue following orders and other suitable orders as this commission feel fit. Order

- 1. to the Government and Public Servants NOT
 - a. to behave as dictators
 - b. to refuse basic human rights of people
 - c. to act against the laws and the Constitution
 - d. to force people directly or indirectly to wear masks, Covid testing and Vaccines

- 2. to stop refusing individuals' rights, freedom, employment, travel, entry to public places, and to stop treating people as untouchables, on the grounds of not having Covid Vaccination Certificate or Negative Covid test Certificate
- 3. to stop false propaganda of the government, public servants, media and press, and celebrities.
- 4. to stop broadcasting news that create panic and stress among public.
- 5. to immediately revoke above mentioned illegal announcements, which were issued by government / government authorities.
- 6. to take criminal actions against following, who involved in abuse of power, violation of human rights, and offensive activities.
 - a. Chennai City Corporation Commissioner, Mr. Gagandeep Singh Bedi
 - b. Chief Education Officer of Chennai District
 - c. Chief Education Officer of Tiruvallur District
 - d. District Collector of Vellore, Mr. Shanmuga Sundaram
- 7. to find out those affected by the compulsive malpractices of Public Servants, and provide appropriate relief for them.
- 8. to issue an order to the Government, to produce the large quantity of traditional covid preventive medicine (invented by Mr. Anandiah of Nellore District, Andhra Pradesh) which was approved by Central Council for Research in Ayurvedic Sciences (CCRAS) and to make it available to people all over the country.
