As far as this Office/CPIO i.e. COVID-19 Vaccine Administration Cell (CVAC)/Undersigned CPIO is concerned, the information/reply is as under:</p> <p>A to C :- Vaccination for COVID-19 is voluntary. However, it is advisable to receive the complete schedule of COVID-19 vaccine for protecting oneself against this disease and also to limit the spread of this disease to the close contacts including family members, friends, relatives and co-workers.</p> <p>COVID Vaccines like other drugs are licensed after due deliberations and consideration of safety data by Drug Controller General of India (DCGI). If anyone is concerned for any specific health reason before COVID Vaccination, please consult a doctor/Health Care Provider.</p> <p>It is duly advised, advertised and communicated by MoHFW through various print and social media platforms that all citizens should get vaccinated, but this in no way implies that any person can be forced to be vaccinated against her/his wishes. Covid Vaccination is voluntary.</p> <p>As per the existing guidelines, there is no provisions for forcing any citizen to book appointment for Covid Vaccination on COWIN or visit Covid Vaccination Center for vaccination. if a person above the age of 18 years visits a Covid Vaccination Centre by his/her choice for vaccination, it implies that she/he is voluntarily coming to the center to get the benefit of Covid Vaccination. Hence, no separate written consent should be required from the person who has voluntarily come to the Covid Vaccination Center, to get the Vaccination.</p> <p>In case, you want to go for an appeal in connection with the information provided, you may appeal to the Appellate Authority indicated below within thirty days from the date of receipt of this letter.
