Subject: Compulsory Informed Consent for Covid 19 Vaccines for Children

We introduce ourselves as a composite group of hundreds of thousands of concerned citizens, doctors, lawyers and parents.

By writing to you, we hope to garner your support, cooperation and engagement in securing a safe environment for our children.

In the light of scientific opinions and studies related to covid19 emerging from different parts of the world, it has become more imperative than ever before that we all come together and work for the larger interest of safety, protection, and benefit of our children.

Keeping this in mind, we as a society must insist on open public debates conducted by independent scientists and doctors who have no conflicts of interest.

Coming specifically to the recently announced proposal of vaccinating children against Covid 19, we have grave concerns that we would like to draw your attention to:

1. Children are not affected severely by Covid 19, as confirmed by many prominent scientists. According to latest sero surveys, all children in India have been exposed to it, and almost all of them have acquired natural immunity which is robust and long lasting.
