

Questions To Be Raised in Parliament (Winter Session 2021-22)**Covid19 Vaccines:**

1. Covaxin and Sputnik manufacturers clearly mention contraindications for pregnant and breast-feeding women. Also, the Covishield manufacturer mentions that not enough studies have been done on pregnant women. **Yet, MOHFW and the Government are recommending these covid-19 shots for pregnant and lactating women. What is the scientific basis for this?**
2. The mainstream media as on Nov. 30 2021 has reported 10,561 covid19 vaccine related deaths. As per studies done in other countries, the actual numbers could be at least 100 times higher. **Several people in the public limelight itself have died.** Some names - Puneet Rajukumar, Tamil actor Vivekh, Avi Barot, umpire Bansal, Sidharth Shukla, Raj Kaushal, Amit Mistry, Manisha Yadav, Sonu Nigam's brother-in-law, Kaizzad, Mahesh Koneru, Rinku Singh, Kalyan Singh, the list is long. **When will the government start an investigation into this matter?**
3. As per CDSCO, they have, in consultation with Subject Expert Committee (SEC) approved COVID-19 vaccines for **restricted use** in emergency situation and **the clinical trials are still ongoing for conclusion of results of complete safety, immunogenicity and efficacy.** If the clinical trials are still ongoing why is the government encouraging people to get injected by these vaccines? **What is meant by restricted use?**
4. All clinical trials have been conducted by covid19 manufacturers in India **only on healthy individuals.** What is the basis for encouraging these shots for the general public, which consists of people with all sorts of health conditions and disease states?
5. All advertisements put out by the government state that the covid19 vaccines are safe and effective. If they are safe, **why has the government given immunity to the manufacturers for deaths and adverse events? What is the scientific rationale and basis for indemnifying covid19 vaccine manufacturers?** This seems very odd given that there are no meaningful short-term studies leave alone mid-term and long-term studies.
6. All advertisements put out by the government state that the covid19 vaccines are safe and effective. If they are effective, why is the government now starting to talk about booster shots? **Does this not mean that the original two doses were in fact not effective?**

7. When will the government release data on **the number of deaths within 14 days of the 1st covid19 vaccine dose and the number of deaths within 14 days of the 2nd covid19 vaccine dose?**
8. CDSCO has clearly mentioned that they have not given permission for clinical trials on post-diseased individuals (that is, those who previously suffered from covid19). **Why then is the government not warning citizens who have suffered and recovered from covid19 to not get injected by the covid19 vaccines? Why is no such alert being issued?**
9. As per Delhi HC ruling in W. P. (C) 343/2019 & CM Nos. 1604-1605/2019 HOD, Preventive Medicine, AIIMS was directed to finalize list of contraindications and risks associated with vaccines to be included in advertisements promoting vaccines. At the moment, campaigns and advertisements by government agencies and the media make absolutely no mention of covid19 risks and contraindications. **Why are Indian citizens being kept in the dark about covid19 vaccine risks and contraindications?**
10. **Why is there no proper AEFI reporting mechanism in India?** In the US, the VAERS system is being populated at a feverish pace since the covid19 vaccines were introduced. Already we can see 18,853 deaths as per the official US VAERS database (a total of 894,143 Adverse Event reports till 12/11/21). In Europe, in just 27 countries, 31,014 death reports are available in the official European Union database EudraVigilance (a total of 2,890,600 Adverse Event reports till 20/11/21). **What are the equivalent numbers in a huge country such as India?**
11. The rates of Myocarditis, Pericarditis, Anaphylaxis, Bell's palsy, Heart attack, Thrombocytopenia/Low Platelet count, Severe Allergic Reactions, Shingles, and Cancer have gone up significantly in the country after the introduction of covid19 vaccines. **What is the government doing in this regard? Is it going to let things be and see its citizens suffer like this?**
12. Covid19 vaccine clinical trials have been sponsored by the manufacturers themselves and by foundations like the Bill and Melinda Gates Foundation. **There are a lot of conflicts of interests here. Why is the government turning a blind eye? Why are government agencies accepting clinical trial data generated by these sponsors?**
13. **How is the government treating covid19 vaccination for 'non-healthy' children with chronic conditions such as eczema, asthma, ADD, ADHD, autism, and so on resulting from previous vaccinations or other causes?** Only healthy children are participants in the clinical trials.

14. An overwhelming majority of covid19 patients in 2021 in India have been vaccinated by covaxin, covishield, or sputnik. **What then is the use of these vaccines?** Why is the government still encouraging people to get jabbed by these injections?
15. What medical facilities and emergency care has the government planned during any door-to-door vaccination drive? **Who will take responsibility for death and suffering during these drives? What compensation will the government pay to aggrieved families?**
16. Why is the government using tax payer money to buy covid19 vaccines when there is no emergency? **Can the government show an uptick in monthly or annual death rates? The death rate is 7.3 in both 2019 and 2020. Why vaccines in that case?**

18. **Why are the covid19 vaccines being administered in 2 doses?** There is no precedent for this in the last 150 years. **Is the government aware of the scientific basis?** Is there a difference in ingredients between the 2 doses?
19. The covid19 vaccine manufacturers themselves openly admit that their vaccines do not stop vaccine recipients from getting infected or transmitting the so-called covid19 disease. They also admit that new variants such as delta or omicron will need more vaccines. **Is the government happy to play along with their games and continue to allow them to keep on selling their untested and unsafe products? They can always fake more variants and mutations and ruin the country with their vaccines.**
20. Are doctors and health professionals in India being trained on recording and monitoring short, medium, and long-term Adverse Events Following Immunization (AEFIs) post covid19 vaccinations? Is this training updated based on new types of AEFIs such as major vascular damage inducing strokes, heart attacks, migraines, and blood clots among dozens of other dangerous adverse reactions that have already adversely affected lakhs across India?
21. **Is the government maintaining data on the number of people who tested covid positive after the 1st dose and the 2nd dose of covid19 vaccination?** Nowadays, it is seen that most people with so-called covid19 symptoms and most people who are hospitalized for covid19 are either partially or fully vaccinated.

22. The ongoing covid19 vaccination drive is a massive experiment on Indians who are being used as guinea pigs for these experimental products. **Given this, why is informed consent not being taken from vaccine recipients?** There is no database of Informed Consent Forms (ICFs). As per ICMR's NATIONAL ETHICAL GUIDELINES FOR BIOMEDICAL AND HEALTH RESEARCH INVOLVING HUMAN PARTICIPANTS (ICMR, October 2017) document, **the rules are very strict when it comes to informed consent, privacy, and confidentiality of participants in clinical trials.** Why are none of these being followed in the case of covid19 vaccines?
23. Sometimes, government agencies mention that Fetal Bovine Serum (FBS) is used during covid19 vaccine manufacturing process. Sometimes, they deny that FBS is used. Is the government aware if FBS is an ingredient in covid19 vaccines? If it is, then it is a big issue for many Indians who worship cows.
24. Covid19 vaccines are based on new and untested technology, **but have taken only a few months to develop.** Vaccines using old technologies themselves take 8 or more years to develop and obtain approval. Why is the government not taking this issue seriously? **Why is the government not waiting for all clinical trials to be completed and all mid- and long-term studies to be completed? Apart from blood clotting, cancer, and other issues, fertility is also another concern that needs long-term studies to be completed.**
25. There is enough evidence from around the world and also parts of India (such as Kerala) that **heavily vaccinated areas are reporting high rates of covid19** (as determined by the RT-PCR test). **Has the government commissioned studies to establish a link between vaccination and high rates of covid19?**
26. Why is the government not spreading awareness through newspapers and media that vaccines and any other medical interventions are voluntary?
27. Why is the government not taking action against companies and certain state and central government agencies for forcing people to get vaccinated by intimidating them? These are serious violations of multiple articles in the constitution and have to be dealt with severely.
28. THE MINISTER OF HEALTH AND FAMILY WELFARE, SHRI MANSUKH MANDAVIYA, IN LOK SABHA said on the 23rd of July 2021 that ""There is however no scientific evidence either from India or globally, to show that children get disproportionately infected with Covid-19 including delta variant. Children, if infected, generally remain asymptomatic or exhibit mild symptoms and do not get severe disease."

Did situation change or new credible empirical/scientific study or fact come up proving threat to children from Covid-19 that **resulted in DCGI's approval of Zycov-D Covid Vaccine on the 20th of Aug. 2021 for children in the age group 12-17?**

- 29. Is there any peer-reviewed scientific study which proves that immunocompromised or comorbid children have extra risk with Covid-19 in comparison to other acute illnesses such as cold, cough or flu?**
- 30. Is there any scientific study which proves that Covid-19 Vaccine helps in the reduction of mortality of immunocompromised or comorbid children?**
- 31. Many countries which implemented Covid-19 Vaccine for under 18-year olds have reported thousands of cases of side-effects including deaths with severe adverse events such as myocarditis, pericarditis and thrombosis which have led to a sharp rise in mortality figures of children in comparison to last year. Reports say that the Covid-19 Vaccines are killing 117 children to protect 1 child from Covid-19. It clearly indicates that risks outweigh the benefits. Why then is the government proceeding with covid19 vaccines for children?**

Health Measures

- 32. TB kills lakhs of people in India every year and the number of cases are close to 25 lakhs per year. Why are masking and distancing and sanitization measures not followed to control the spread of TB in India? Why are these so-called health measures followed only for covid19? After all, TB is a much more prevalent contagious disease.**
- 33. Throughout the history of mankind, people with no symptoms have always been considered to be healthy people. How is it that in the covid era, healthy people are suddenly being looked at as possible carriers of this**

covid disease? How can asymptomatic people be a threat to anyone when there is no proof that even people with symptoms can make others sick? **Is the government not worried about such an odd way to treat healthy people?**

34. We have not heard of a single case of someone who suffered from covid19, did not get vaccinated, and suffered again from covid19. **Are there any documented cases of unvaccinated people in India who suffered from the covid19 disease on two separate occasions?**
35. With respect to the ongoing health scare, we observe that even though people are being asked to follow physical distance guidelines, they are being allowed to walk or move in a line one after the other without any wait time. Why are people not being asked to wait 48 hours or longer before occupying the same space that was occupied by someone else just a moment or two before. As per the science, deadly viral particles can hang and spread around for long periods of time. **Is the government aware of such anomalies in the official narrative which make absolutely no sense?**
36. What are the reasons for discouraging alternative treatment protocols for curing people who have had covid19 symptoms over the past 20 months? **Why is the government only encouraging western treatments and vaccines when there are 1000s of years of rich and successful history of traditional healing methods in India for any health condition?**
37. Several seroprevalence surveys have been completed in India and they clearly show that a vast majority of the population were affected and have recovered with robust immunity from covid19. Given this, what is the need for universal vaccination by covid19 vaccines?
38. How many children below the age of 18 died due to the covid19 'dis'ease in 2020 and 2021 in India? **How many children below the age of 18 died due to TB in 2020 and 2021 in India?**

Masks

39. There are hundreds of studies available from around the world since March 2020 on the massively detrimental effects of wearing face coverings. **Why do government agencies still insist on this harmful measure? Do they not know that humans were born to breathe clean fresh air for maintaining good health?** Did the committee that decided this not look into the simple fact that viral particles (even if they can cause harm and are pathogenic) are **tens**

of hundreds of times smaller than the pore sizes of cloth, surgical, and N95 masks?

40. What is the rationale and **scientific basis for asking Indian citizens to follow covid appropriate behavior (such as masking, distancing, and so on) even after they have received all doses of the EFFECTIVE covid19 vaccines?** This makes absolutely no sense and it is a pity that this charade is being played out throughout the country. **What is the real reason for masks?** We know it cannot do any good as viral particles (even if they can cause harm and are pathogenic) are tens of hundreds of times smaller than the pore sizes of cloth, surgical, and N95 masks?
41. No science is required for even a child to realize and be aware that masks severely restrict the flow of oxygen and that by wearing masks one inhales carbon dioxide and toxins that are supposed to leave the body. **Why are government agencies still recommending this inhuman measure which does nothing but spoil the wearer's health, physically and mentally?**
42. It is estimated that up to 5 billion masks are discarded around the world on a daily basis. Apart from the environmental catastrophe, it is strange that no biohazard bins are seen across the length and breadth of the country. Under strict handling procedures, **masks would be carefully collected and properly disposed of given the purported transmission claims. Yet, this is not being done anywhere in the country. Why is the government and its agencies continuing to fool the public?**

5G Radiation

43. ICMR has indicated that as 5G network of cellular communication technology is still not launched in India, **no studies have been done on the effect of 5G radiation on the human body. When is this being planned to be done?** We are hearing that 5G is going to be rolled out shortly. Worldwide, there are more than 1000 papers available on the seriously detrimental effects of 5G on the human body. This is a very serious matter and cannot be brushed under the carpet.

Testing

44. RT-PCR test kits currently in use in India are still under emergency use authorization. **Are government agencies taking steps or have they already taken steps to move towards full approval? If not, why not?** It has been 20 months.

45. Courts in many countries (Austria and Portugal to name two) have declared that the RT-PCR test is highly unreliable and should not be used to detect covid19 illness. The CDC in the US is also scrapping this test from Dec. 31 2021. **Why is the Indian government continuing to use this faulty test?** The media is keeping the fearmongering going with meaningless case numbers.
46. Government agencies talk about variants such as delta and give out statistics based on this. All this sounds unbelievable as the RT-PCR test being used to detect sarscov2 is under emergency use authorization. **How can something under EUA detect variants?** Can the government explain this?
47. 97.2% who tested positive till Aug. 2021 were asymptomatic (that is, they were healthy) as can be seen from this table supplied by ICMR:

Autopsies

48. **Why have hospitals shied away from doing autopsies both during the so-called first wave in Apr 2020 and the 2nd wave in Apr-May 2021? We still do not have a clear scientifically proven reason for deaths during the 1st and 2nd waves.**
49. Why are hospitals shying away from conducting post-mortems on people who have died after covid19 vaccination? **Why is the government not insisting on autopsy for every post-vaccine death?**

Miscellaneous

50. As per the Union Minister of State (Independent Charge) Science & Technology, Jitendra Singh, so far one lakh Genome and DNA sequencing has been done for Covid-19 by the Department of Biotechnology (DBT) while five Covid biorepositories with 57,000 samples have been made available for the academia and industry for R&D and product development. **Did the**

government take consent from individuals/participants for this collection and sequencing?
