Subject: Letter of Liability for School Principals, Administrator and other Authorities, forcing children to take experimental corona vaccines and thereby putting their life in danger

Dear Sir/Madam.

We, concerned parents and citizens of India, would like to bring to your notice that while the Central Government has given permission to vaccinate children in the 15-18 years age group, it is not mandatory for them to take the experimental Covid vaccine.

Please find attached herewith, a letter from Indian Bar Association, duly signed by Adv. Dipali Ojha, clearly outlining the scientific and legal aspects of vaccinating children. Please find a summary of the letter asunder;

- 1. Covid 19 vaccination is purely voluntary for Citizens of India as per Central Government guidelines, affidavits filed in court as well as multiple court orders as referenced in the letter.
- 2. Covid 19 Vaccines have been found to cause fatal and severe side effects, which may be 4 to 10 times more fatal than Covid itself. Multiple deaths of children post Covid injection in the US have been mentioned in the letter.
- 3. Many deaths have occurred post Covid vaccination in young adults in India as well and the following link provides a list of more than 10,800 deaths following covid vaccination as reported in media. Link:

- 4. There is a lack of reporting and monitoring of Adverse Events Following Immunization in India as it is apparent by statement by Justice Shri D. Y. Chandrachud and comparison of Adverse Events data from the UK.
- 5. Based on the available science and evidence, honest experts from India and abroad are against the vaccination of Children including member of National Technical Advisory Group on Immunisation (NTAGI), Dr. Jayprakash Muliyel.
- 6. Informed Consent is a legal right of every individual and children cannot be given any vaccine or any other medical treatment without the written informed consent of their parents.
- 7. The school is urged to not promote these experimental vaccines that may cause irreversible damage to children. They are also urged to not follow any illegal and unconstitutional order which is passed by any local authorities. They are finally requested to not indulge in any negligence, carelessness or show any over-enthusiasm which may put the life of children in danger.

We would like to categorically and explicitly state the following:

- i. Vaccinating children is an unscientific and illogical decision;
- ii. No authority can impose any condition to get vaccinated;
- iii. Forcing to get vaccinated to avail certain services is a civil wrong and criminal offence punishable under Section 166, 188, 341, 342, 109, 323, 336, 511, 115, 120 (B), 34, 52 etc. of IPC and Section 51(b), 55 of Disaster Management Act, 2005;
- If any children die due to vaccination then concerned doctors & iv. authorities, including school management will be liable for charge of murder punishable under Section 302 of IPC;



- Except the written consent of parents, the children should not be v. vaccinated. Informed consent of parents is mandatory;
- vi. The Doctors or public authorities promoting vaccination are bound to explain and publish the death causing and other side effects of vaccines;
- vii. Without such publication and without giving full information if any children are vaccinated, then it is an offence of cheating punishable under Section 420, 120 (B) & 34 of IPC; In the said prosecution, victim parents can demand compensation of any amount without paying court fee, by invoking section 357(3) of Code of Criminal Procedure Code;
- viii. As per section 120 (B) all the school authorities, Principal, Doctors, Nurses, ASHA (Accredited Social Health Activist) workers etc. will be equally responsible for all the offences for their act of commission and omission. [Raman Lal Vs. State of Rajasthan 2020 SCC OnLine Raj 226, State of Odisha Vs. Pratima Mohanty 2021 SCC OnLine SC 1222]
  - ix. As per section 52 of IPC nothing can be said to be done in good faith if it is not done with due care and caution.

It is important to note that illegal vaccine mandates by various state and local authorities are currently under deliberation in the Supreme Court and various High Courts. These orders are not only in violation of guidelines of Central Government but also of our Constitutional Rights. We humbly urge the schools to not follow any such illegal orders passed by over enthusiastic Government officials, who may have some ulterior motives for passing unlawful orders.

Please find below details of deaths in children that have happened in India post Covid injection since they began the vaccination program on 3-Jan-2021:

1. On 4-Jan-22, **12th standard** student **Tarni Lahre** from Lalpur village, Bilaspur, Chhattisgarh, took her 1st dose of covid vaccine at her school and died the same day at around 9 pm in Lormi Hospital.

2. 17-year-old girl Kondepogu Namitha, took Covid vaccine on 3-Jan-22, the day when India began vaccinating the 15-18 years age group. The girl died on 4-Jan-22. She was from Moguluru Village, Kanchikacharla Mandal, Krishna District, Andhra Pradesh

3. 17-year-old healthy 11th standard student, Luv Kumar Sahu, got the 1st dose of covid vaccine on 3-Jan-22 (the day when India began vaccinating the 15-18 years age group) at Pandadah school. He complained of headache, dizziness, vomitting. His health deteriorated further, his condition became critical at civil hospital and he died on 4-Jan-22 on his way to another hospital.

4. Anuradha Makwana (16 years), from Bishan Khedi village of Tarana tehsil of Ujjain district, was a student of class 9 of Government Higher Secondary School. After covid vaccination on 5-Jan-22, her health suddenly deteriorated on 6-Jan, She was taken to Tarana Hospital where the doctors referred her to Ujjain for Intensive Treatment, but she died en route to Ujjain.

At the very least, you are now well informed of the liability placed upon your entire School administration and management incase of any evidence of coercion or forceful vaccination as well as if there is any unfortunate severe/fatal adverse event in children.
