Subject: Appeal for your Immediate Attention to Following 14 Demands on Certain Covid-19 Measures, Protocols & Treatments adopted by the Government in Delhi & also in another States & Centre

This is continuation of our earlier letter & visit at Delhi Secretariat to meet your good self on dated 20th January 2022. We however could not meet you, neither subsequently received any response, nor any invitation/intimation from your side for any meetings/discussions or any update on actions taken by your Govt & party on the captioned Subject & our appeal therein

In view of your complete disregard to our earlier appeal requesting you to stop several Covid-19 measures, protocols & treatments that was & is severely hurting the Delhi residents & citizens of India's livelihood, finances, mental, physical & psychological health & well-being, we are sending you once again this letter with our updated following appeals & we request your time & availability at 2:00 PM on 17th February 2022 at Delhi Secretariat to meet us & discuss on the same

We would like to remind you that you & your party are an elected representatives of us, Citizens & it is your duty to meet us & understand our appeal

Vaccine Mandates, Coercion & RT-PCR Tests		
1.	Stoppage of all forms of Discrimination based on Vaccination Status	<ul style="list-style-type: none">It is now evidently clear that vaccines are not effective in either preventing infection or its transmissionsFurther in India, it is also not "Fully approved" & only has "Permission for Restricted Use"The Central Govt. in its affidavits to Supreme Court in November 2021 & January 2022 has clearly said that COVID-19 vaccination guidelines issued by the Union Health Ministry (MOHFW) is Voluntary & do not envisage forcible vaccination without obtaining the consent of an individual. It never forced anyone to get "vaccinated against their wishes".Central Govt. Submitted in Parliament over 1000+ deaths due to vaccines & over 70K adverse effects <p>In view of above, any form of discrimination on account of vaccination status is unjustified, unlawful, in-human and is depriving livelihood and causing harm to the mental or physical health to those who have chosen alternate medical treatment/prevention & decided not to take vaccines</p>
2.	Stoppage of all Forms of Vaccine Coercion on all adults & Children	Schools are forcing students & their parents/wards & offices/firms forcing their staff to get vaccinated.

		<p>Delhi Govt. should immediately take legal action against all such schools, colleges/educational & other firms/offices/establishments that are imposing any such conditions & release circulars clarifying No student or staff should be deprived from attending any classes, taking exams or job/employment. For. E.g., Maharashtra Education has issued a circular asking schools to seek informed Consent & remove mandatory clause of vaccination for attending school/exams</p> <p>We also would request you to please withdraw the Delhi Govt./DDMA order on School/College Teacher's mandatory vaccination</p>
3.	Include Alternate Medical Treatments to Covid-19 Protocols	Govt. should not demonstrate any form of bias against or in favour of any medical practice & promote reasonable & assessed AYUSH treatment & other alternate protocols.
4.	Stoppage of Mandatory Use of Masks & Fines	Use of masks through-out the day can be injurious to health & be immediately made voluntary. If you do not agree, then please advise why you & other politicians organising rallies with most people coming there without masks & they(politicians) appearing in public without masks including yourself & Shri. Narendra Modi
5.	Stoppage of Quarantine Procedures	Quarantines have proven ineffective & is causing severe difficulties during travels or otherwise, we request the same to be immediately stopped
6.	Stoppage of RT-PCR Tests to as a Means to Diagnose Covid	As is evidently clear that the RT-PCR tests is unable to distinguish between Covid & other ILI(Influenza Like Illness), flu, hence the use should be immediately withdrawn. Note that CDC has already withdrawn RT-PCR tests for Covid
Stoppage of All Forms of Lockdowns/Lockdown Related Restrictions		
7.	Stoppage of all forms of Restrictions i.e Lockdowns, curfews	All such forms of restrictions are hurting most, the people who are at the "bottom of the Pyramid" & causing much larger challenges of job, income, livelihood, education & including their family's well-being. Hence Such measures should be immediately withdrawn & not be re-introduced in future
8.	Immediate Resumption of all Forms of Sports Activities/stadiums/Educational Institutions for students, players & spectators	<p>The shutdown of Offline School, education etc. has deprived our children of effective education, coaching, & especially for those families which cannot afford laptops & mobiles for each of their children or do not have adequate income to pay for internet charges in case of online remote classes</p> <p>Additionally, shutdown of Sports/fitness centres, gyms/stadiums have deprived & causing mental agony & harm to physical & mental health of children, youth & all other fitness & health focussed citizens</p>
Informed Consent, Ingredient Disclosure & Recording of Adverse Effects Following Vaccination (AEFI)		
9.	Vaccine Centres to Expressly Disclose Potential Side effects including deaths, ingredients affecting religious sentiments or those who oppose any form Animal Slaughter	<p>Now that the Central Govt, in its response in Parliament has stated that there has been 1000+ deaths due to vaccines & over 70K+ adverse effects due to such vaccines, hence the Govt. should ensure that all such vaccine Centres administering vaccines Should</p> <ul style="list-style-type: none"> • Inform that these Vaccines are Voluntary • Seek "Informed Consent" before administering the vaccines • Inform incumbents of <ul style="list-style-type: none"> ○ Possible adverse side effects following Vaccination ○ & Disclose all Ingredients/Processes used especially those that can hurt religious sentiments or be against religious/other practices (As per an RTI disclosure, Vaccine manufacturing

		process uses Serum (Animal fluid)) from New-born Calf (i.e Cows, buffalo, bull). Such Information is Most essential to be disclosed to those who are against Animal Slaughter especially bovines (e.g., Hindus, Jains)
10.	Vaccination Promotion/Advertisement to also include Statement/Disclosure on Adverse Effect Following Immunization (AEFI)	With the Central Govt. acknowledging Adverse Effect following vaccines (AEFI) in Parliament (As above), it is the responsibility of all Government/institutions administering & promoting vaccines to Include in all such Advertisements & Communication full information on possible vaccination Adverse Side Effects, so people can take fully informed & voluntary Decision on whether to take vaccines or not. This is especially relevant in here as such vaccines are still under trial & only given "Emergency Use Authorisation/Permission for Restricted Use"
11.	COWIN Portal to Allow Direct Online Submission of Any Adverse Effects by those Vaccinated	The Process of recording, reporting of adverse effect following Immunisation(AEFI) in case of Covid-19 vaccines is far from desirable & Govt. in interest of such people who have suffered or may suffer in future due to vaccine adverse effects and also to improve the vaccine efficacy immediately create a web page on COWIN/any other Portal to directly allow those/their relatives who may/may have had suffered any adverse side effect or death to record, report these & obtain a registration number for follow-ups
12.	AEFI Program Management on Covid-19 Vaccine be Undertaken by an Independent Body	Currently the government/institution that is conducting vaccination has a conflict of interest to also promote AEFI & obtain receipt, record & report of that. The Government to immediately give the work of receipt, recording & reporting to an independent agency
Compensation Announcement Against Adverse Effect & Losses (job, money, etc) Due to Lockdowns		
13.	Govt/Vaccine Manuf.to Announce Compensation for Adverse Effects from Vaccines (AEFI)	Since the Government is promoting & advertisement the benefits of vaccines, it should also announce Compensations if any such individual has suffered adverse side effect or death due to vaccination
14.	Govt. to Announce to Compensate all Private workers, employers, traders, businesses, NGOs, entrepreneurs, self-employed for the loss of income due to Lockdowns & Restrictions	The Govt. must think for the welfare of its state than just for Govt. Servants, ministers, legislatures who have been paid in full, salaries including pay hikes & bonuses during these lockdowns & restrictions The Government must consider all as equal & compensate all such persons who have suffered to the full extent of the loss
