

Quit India, WHO - World Harassment Organization

- WHO serves interests of Big Pharma well as others such as the tobacco industry, the nuclear energy industry, and the gene modification (GMO) industry by recommending their products and causing severe harm to millions of people.
- WHO has become a global marketing and delivery agent for vaccines and medicines for Big Pharma. Today, 80% of the WHO budget comes from the U.S. government, the Bill and Melinda Gates Foundation, and Big Pharma who dictate and control the WHO policies and expenditure areas. Expensive WHO get-togethers are often hosted by pharma companies for lobbying & networking.
- The Swine Flu 'fake' pandemic. In 2010, WHO was declared fraud by the council of European Parliamentary Committie after it had connived with pharma comapies to declare a mild flu dangerous, in order to sell drugs and vaccines.

A notice has been served on January 7th 2022 by the Indian Bar Association to WHO & Dir General of WHO Dr Tedros Adhanom Ghebreyesus and chief cientist Dr Soumya Swaminathan for their wrongdoings and nexus with Pharma companies and toxic organizations like the Bill & Melinda Gates Foundation, GAVI, The Rockefeller Foundation, Sanofi, GSK, Merck Novartis and Purdue

Following definitions were changed to suit Big Pharama agendas

- **Pandemic.** It was changed in 2009, just before the outbreak of the Swine Flu. They decided to omit the death and severity factors in a pandemic. It is very easy to declare a pandemic now based on the number of inections which could be forged as in the case of Covid19. Any simple flu can be a pandemic, giving WHO constant emergency totalitarian powers over all 198 signatory countries. They will be forced to act at the whim of WHO. If the pandemic is declared at level 6, it would become obligatory for the countries to purchase vaccines.
- Herd immunity. According to the new definition it could be achieved only through vaccination ignoring the role of natural immunity.
- **Sick person.** This was changed to accommodate for 'asymptomatic' transmission. Earlier, only those with symptoms were deemed sick but WHO called healthy people "sick and asymptomatic carriers" who could spread infection, based on a positive PCR test.
- Vaccine. They called the Covid gene therapy a vaccine. This injection does not fit the traditional definition of a vaccine.

Criminal Recommendations

- They hid the fact that long Covid can be a result of side effects from wrong treatment and medical protocols and not the flu per se. For example, it has been proven that Remdesivir causes liver and kidney damage. Yet, it was prescribed to thousands of patients.
- The Global Pandemic Treaty, proposed by the WHO, is another attack by the Globalist Cabal to monopolise health systems worldwide. Under the guise of improving Global Pandemic response, the plan is to allow the WHO to seize executive governance power over their member states in the case of a Pandemic.
- The RTPCR test, according to its inventor, Kary Mullis, can be used only for research and not for diagnosis. It gives many false positives depending on the CT value used to run the test. Yet, this test was recommended by WHO to diagnose Covid. People were randomly tested without symptoms. Many healthy people were forced to quarantine on the basis of this test, were mistreated, resulting in disruption of lives and livelihoods.
- Calling the Covid vaccines safe and effective when they are experimental and do severe harm and cause deaths. Current covid vaccines have caused millions to suffer adverse effects such as systemic muscle pain, Bell's palsy, Guillain Barre Syndrome, neuritis, chronic pain, paraesthesia, inflammatory bowel disease, myocarditis, thrombosis (blood clots), thrombocytopenia and narcolepsy, a chronic neurological disease that especially affects adolescents. However, WHO and leading medical journals have refused to publish scientists' reports of these.
- WHO recommended wearing of masks when there are no studies to prove its effectiveness and safety, as per an Indian RTI. On the other hand, there are large number of studies that prove they are highly dangerous and may lead to serious diseases like asthma, fibrosis and cancer.

Modus Operandi - No Accountability

- WHO has been declaring fake or exaggerated pandemics, giving wild predictions of huge numbers of deaths based on computer models.
- Suppressing drugs and alternatives that may actually cure the disease.
- It has been mandating tyrannical non-researched methods such as lockdowns, masks, quarantines resulting in loss of livelihood and starvation. They use media to spread the lies, create fear and panic, and push toxic drugs and experimental vaccines that serve interests of Big Pharma.
- Vaccine induced adverse effects are highly underreported. Vaccine injuries get covered up as coincidences or pre-existing sickness or they are labeled as new diseases, for example, polio vaccine induced polio was called spinal meningitis or non-polio acute flaccid paralysis. Covid vaccine induced shingles are called monkey-pox.
- Introduction of new drugs and vaccines for the new diseases.
- It's a vicious circle.
