Press Release

A press conference was called by Doctors from across India to discuss the ongoing Medical Crisis associated with the Covid 19 Vaccine.

Date: 10th September '22

Time: 11:00 AM to 02:00 PM

Venue: Via Video Conference.

The Doctors presented a Manifesto (annexed herewith) signed by Medical Professionals from **34 Countries** worldwide. The Manifesto was first drafted by a Spanish group of Doctors, Medicos por la Verdad. Dr. Natalia Prego Cancelo, spearheaded this effort to draft and then unite Doctors & Scientists from around the World. Groups like World Council for Health, World Doctors Alliance, America's Frontline Doctors, World Freedom Alliance, Caring HCWs Coalition, Akasha ConCiencia, APSIIN, Awaken India Movement, Universal Health Organisation and others have come together. Countries that are participating in the Declaration are: Spain, Italy, Portugal, Holland, Switzerland, Sweden, Norway, Hungary, Ireland, Denmark, Germany, Poland, Austria, Mexico, Argentina, Brazil, Bolivia, Uruguay, Paraguay, Chile, Peru, Honduras, Guatemala, Colombia, Ecuador, Puerto Rico, Costa Rica, South Africa, Zimbabwe, Israel, Canada, USA, UK, India

The Manifesto demands that the following measures be undertaken on an urgent basis:

1. A worldwide 'stop' to the national inoculation campaigns with the products known as "COVID-19 vaccines".
2. Investigation of all sudden deaths of people who were healthy previous to the inoculation.
3. Implementation of early detection programmes of cardiovascular events which could lead to sudden deaths with analysis such as D-dimer and Troponin, in all those that were inoculated with the products known as "COVID-19 vaccines", as well as the early detection of serious tumours.
4. Implementation of research and treatment programmes for victims of adverse effects after receiving the so called "COVID-19 vaccine".
5. Undertaking analyses of the composition of vials of Pfizer, Moderna, Astra Zeneca, Janssen, Sinovac, Sputnik V and any other product known as "COVID-19 vaccines", by independent research groups with no affiliation to pharmaceutical companies, nor any conflict of interest.
6. Studies to be conducted on the interactions between the different components of the so called "COVID-19 vaccines" and their molecular, cellular and biological effects.
7. Implementation of psychological help and compensation programmes for any person that has developed a disease or disability as a consequence of the so called "COVID-19 vaccines".

8. Implementation and promotion of psychological help and compensation programmes for the family members of any person who died as a result of having been inoculated with the product known as “Covid-19 vaccines”.

Highlights of the Press Conference:

Dr. Amitav Banerjee, MD, Community Medicine, PD in Clinical Epidemiology:

Upto 84% increase in deaths, in the USA, among Adults aged 24 to 44 years. Mumbai has reported a 6 times increase in Heart Attacks. As scientists we will not claim that these are all due to vaccines but we demand an investigation and look at this data as a Red Flag.

Dr. Veena Raghava, MBBS, DA:

In India, about 90% vaccines administered are of Covishield and 10% of Covaxin. Covishield, the same as AstraZeneca, has been banned or age restricted in Germany, Sweden, France and 15 other countries. It was totally rejected in the US. It was hence dumped in India. (She mentions the ingredients listed in data sheet of both the vaccines and some of their known adverse effects, for example, Aluminium hydroxide can cause neurodegeneration, Alzheimer, Parkinson's disease, Autism.)

Dr. Praveen Saxena, Radiologist & Clinical metal toxicologist, MBBS, DMRD Osmania, FCMT:

In 2002, 30 vaccines were developed for Coronavirus after the otherbreak of SARS-Cov. They shortlisted 4 vaccines and gave it to Ferrets. Initially there was extraordinarily good immune response. After some time when ferrets were exposed to any other virus, they started having problems. This Antibody Dependency Enhancement mechanism was well defined when RSV vaccine were given to children in 1960. They had to ban the RSV vaccines after two children died after being exposed to a wild virus. These SADS deaths (Sudden Adult Death Syndrome) cannot be just written off. We need to have the data here.

Dr. Sudha Chepyala, MBBS, MD (USA):

It is my clinical observation, from my patients in the USA and India, that a lot of patients are developing severe autoimmune disease like symptoms. We are seeing these symptoms globally. What has changed to connect the similarity of symptoms around the World?

Dr. Gautam Das, MBBS, General Physician:

Some of our patients informed us that their close relatives or friends just collapsed or had to be hospitalised but they didn't report it. In the absence of wide publicity of the Government on how to register side effects or deaths, most people have been victims. They did not report it either out of fear or ignorance.

Dr. Megha Consul, MD, DNB Pediatrics:

I have been seeing an increase in the number of babies which are born with unexplained cases of infection. All other vaccines till date have been given last to Pregnant Women. The Covid

vaccines are untested, unresearched, with no long term safety data and are being given to pregnant women by actually telling it is good for them. This is wrong on so many levels. Anybody with an ounce of humanity can imagine what has been done.

Dr. Lalit Anande, MBBS, PG Diploma in Clinical Research

We are seeing an explosion of cancer, tuberculosis, cardiac problems but nothing is being documented! The regulatory bodies, who conduct clinical trial audits are doing nothing because of some higher pressures.

Adv. Nilesh Ojha, President – Indian Bar Association

*As per law, the acts of the vaccine companies and bureaucrat, are an offense of a criminal nature. Many of the prayers of the manifesto are on the verge of being granted by Government of India. On 2nd Sept. Kerala High Court has directed GoI to create mechanism to compensate persons who are dying because of side effects of the vaccines. Supreme Court has served notice to Union of India in the case of Rachana Gangu. Bombay High Court has issued notice to all respondents in the case of Dr. Snehal Lunawat who died after taking Covishield. **I hope that, the mission of transparency sending these (vaccine) mafias, who are playing with the lives of humanity, to jail, will very soon be completed.***

Dr. Arvind Kushwaha, BSc, MBBS, MD

*We are recording AEFIs across the World and they are leading to deaths, cardiac issues, cancers etc. In the past we have seen some vaccines, where there were problems during the trials itself, which made authorities stop the vaccines, like the Rotavirus vaccine. The Covid vaccine have not served the two purposes of either being Safe or being Effective. In India out of 1087 serious adverse events recorded from March '21 to March '22, there were 387 deaths and 700 hospitalisations, 90% had covishield and 10% took covaxin. 50% of the deaths were related to Heart ailments. 75% and above were labelled as “Coincidental Deaths”. We should not be labelling something without conducting any investigation, post mortem, pathology tests etc. We estimate about 38,000 – 41,000 deaths that should have happened in India, based on the assumptions of underreporting of Adverse Events in USA and difference of ratio of AEs reported vs vaccines administered in India and abroad. **Stop vaccinations forthwith, no further vaccines for children, a very good adverse event reporting system should be put in place and investigate all deaths happening henceforth to rule out the role of vaccines.***

Dr. Banu Prakash, Neurosurgeon, MBBS, MS, MCh.NS, PGIMER

He shared his digitally signed Exemption certificate for Covid vaccine in social media as open source. He also shared some examples of upto 150 AEFI cases he has personally reported. The AEFI form needs to be circulated to everybody so that everybody knows how to report adverse events and to create awareness amongst Doctors and Hospitals. Until we give feedback to people in authorities, we will never be able to ensure awareness. Many of these people are being misled by propaganda that everything is ok and there will be no problems.

For his outspokenness, Bengaluru MUNICIPAL commissioner filed a complaint to Karnataka medical council. After sharing evidences and many emails from supporters, and after attending hearings every month for 6 months, they have left the matter under review, while the complainant himself was removed from his post. In our Neuro club case presentations, I have forced them to include history of covid injections and infections.

This is what we need to work on:

1. AEFI form for death & disability by the treating doctor.
2. Treatment at patient choice of hospital, Compensation for all AEFI from government and vaccine company.
3. Legal support for fight is the people in the government doesn't initiate this.
4. Demand for public participation before policy making at all levels- citizen, health care workers n people in policy making before imposing orders.

DECLARATION OF INTERNATIONAL MEDICAL CRISIS DUE TO THE DISEASES AND DEATHS CO-RELATED TO THE “COVID-19 VACCINES”

We, the medical doctors and scientists from all over the world, declare that there is an international medical crisis due to the diseases and deaths co-related to the administration of products known as “COVID-19 vaccines”.

We are currently witnessing an excess in mortality in those countries where the majority of the population has received the so called “COVID-19 vaccines”. To date, this excess mortality has neither been sufficiently investigated nor studied by national and international health institutions.

The large number of sudden deaths in previously healthy young people who were inoculated with these “vaccines”, is particularly worrying, as is the high incidence of miscarriages and perinatal deaths which have not been investigated.

A large number of adverse side effects, including hospitalisations, permanent disabilities and deaths related to the so-called “COVID-19 vaccines”, have been reported officially. The registered number has no precedent in world vaccination history.

Examining the reports on CDC’s VAERS, the UK’s Yellow Card System, the Australian Adverse Event Monitoring System, Europe’s EudraVigilance System and the WHO’s VigiAccess Database, to date there have been more than 11 million reports of adverse effects and more than 70,000 deaths co-related to the inoculation of the products known as “covid vaccines”.

We know that these numbers just about represent between 1% and 10% of all real events.

Therefore, we consider that we are facing a serious international medical crisis, which must be accepted and treated as critical by all states, health institutions and medical personnel worldwide.

Therefore, the following measures must be undertaken on an urgent basis:

1. A worldwide ‘stop’ to the national inoculation campaigns with the products known as “COVID-19 vaccines”.
2. Investigation of all sudden deaths of people who were healthy previous to the inoculation.
3. Implementation of early detection programmes of cardiovascular events which could lead to sudden deaths with analysis such as D-dimer and Troponin, in all those that were inoculated with the products known as “COVID-19 vaccines”, as well as the early detection of serious tumours.
4. Implementation of research and treatment programmes for victims of adverse effects after receiving the so called “COVID-19 vaccine”.

Consequently we declare that we find ourselves in an unprecedented international medical crisis in the history of medicine, due to the large number of diseases and deaths associated with the “vaccines against Covid-19”. Therefore, we demand that the regulatory agencies that oversee drug safety as well as the health institutions in all countries, together with the international institutions such as the WHO, PHO, EMA, FDA, UK-MHRA and NIH respond to this declaration and act in accordance with the eight measures demanded in this manifesto.

This Declaration is a joint initiative of several professionals who have been fighting for this cause. We call on all doctors, scientists and professionals to endorse this statement in order to put pressure on the entities involved and promote a more transparent health policy.
