Subject - Sudden deaths due to Cardiac arrests/Heart Attacks in both young and old people without any warning.

Dear Madam,

- 1. Thank you for bringing this to the notice of ICMR to do research on this alarming situation of people dying on the spot.
- 2. Kindly note in your letter you are writing "these deaths are connected to covid -19 " last line of Para 1 and point no 3 - " details of steps taken to study the long term impact of covid-19 virus on the health of people ".
- 3. The above statement that these deaths are due to covid -19 disease is totally incorrect.

These deaths are happening due to Myocarditis and Pericarditis (Inflammation of heart tissues) due side effects to Covid-19 Vaccines.



- 4. It is now well recognized in the world by WHO, CDC and many Governments like Japan and USA (state of Florida) that cardiac arrests due to covid-19 vaccines are happening after covid -19 vaccines.
- 5. In fact after only 1 death of a young boy in Norway in March 2021, 21 countries have banned/ age restricted the Astrazeneca Covishield vaccine in Europe. In most of the countries Covishield is not given below 40 years of age including UK from where Astrazeneca has developed this Covishield vaccine.
- 6. That, parents & family members of deceased have filed various claims in the Courts for appropriate action and compensation from vaccine companies, doctors and responsible public servants who are involved in giving vaccines to the citizen under deception by suppressing the death causing side effects and other serious side effects causing life time disabilities.

8. WHO and CDC has already warned of serious side effects of Myocarditis and Pericarditis resulting in heart attacks and cardiac arrests -

CDC -

Myocarditis and pericarditis after COVID-19 vaccination are rare. Myocarditis is inflammation of the heart muscle, and pericarditis is inflammation of the outer lining of the heart. Most patients with myocarditis or pericarditis after COVID-19 vaccination responded well to medicine and rest and felt better quickly. Most cases have been reported after receiving Pfizer-BioNTech or Moderna (mRNA COVID-19 vaccines), particularly in male adolescents and young adults

Is there a link between some COVID-19 vaccines and myocarditis and pericarditis?

There have been reports of very rare cases of myocarditis and pericarditis following mRNA COVID-19 vaccines (Pfizer and Moderna), most often after the second dose. While myocarditis and pericarditis can be caused by many factors, the currently available data suggest there is a potential relationship between these symptoms and the vaccines.

Although we encourage all citizens to receive the COVID-19 vaccination, it is not compulsory or mandatory. Vaccination will be given only with the consent of the person to be vaccinated after the information provided. Please get vaccinated of your own decision, understanding both the effectiveness in preventing infectious diseases and the risk of side effects. No vaccination will be given without consent. Please do not force anyone in your workplace or those who around you to be vaccinated, and do not discriminate against those who have not been vaccinated."

11. An observational paradox in the study was that the participants who took two doses of COVID-19 vaccination had higher odds of developing Long COVID.

A study was conducted at All India Institute of Medical Sciences (AIIMS) Bhubaneswar, a tertiary care government hospital and research institute for Prevalence, characteristics, and predictors of Long COVID among diagnosed cases of COVID-19 (pre print)

Data was accessed from the AIIMS Bhubaneswar COVID-19 screening OPD database and records of patients admitted due to COVID-19.

By Milan Sharma: The United State's Florida Surgeon General Dr Joseph A Ladapo has advised people, especially males aged 18 to 39, not to receive mRNA Covid vaccines, as they increase the risk of cardiac-related deaths. He said those with preexisting cardiac conditions, such as myocarditis and

pericarditis, should take extra caution when making this decision. The top doctor recommended against the use of such vaccines, citing a study.

The Florida Department of Health (Department) conducted an analysis through a self-controlled case series, which is a technique originally developed to evaluate vaccine safety.

The analysis found that there is an 84% increase in the relative incidence of cardiac-related death among males 18-39 years old within 28 days following mRNA vaccination. With a high level of global immunity to Covid-19, the benefit of vaccination is likely to be outweighed by this abnormally high risk of cardiac-related death among men in this age group. NonmRNA vaccines were not found to have these increased risks.



13. Studying the safety and efficacy of any medications, including vaccines, is an important component of public health," said Surgeon General Dr Joseph Ladapo. "Far less attention has been paid to safety and the concerns of many individuals have been dismissed – these are important findings that should be communicated to Floridians."

14. Research proved in 2 lakhs unvaccinated people that the people who had previous covid infection did not show any rising incidence of myocarditis.

The Incidence of Myocarditis and Pericarditis in Post COVID-19 Unvaccinated Patients-A Large Population-Based Study

A research conducted in Israel on almost 8 Lakhs unvaccinated people out of which 2 lakhs were recovering from covid -19 infection and balance 6 lakhs had no covid infection. The aim was to study the incidence of postacute COVID-19 myocarditis and pericarditis. The data shows-

Only Maharashtra Data -

- A. 18% increase in death due to heart diseases 8702 more deaths in the post vaccinated year 2021-2022.than 2020-2021.
- B. 32% increase in Acute heart diseases including acute cardiac emergencies - 27870 cases more in the post vaccinated year 2021-2022. (vaccination started in Jan 16 2021)
