Subject : (i) Parliamentary Committee According to the 72nd report of IPC, to take legal action under IPC 218, 201,302, 304, 409,120(B), 34 etc.

- (ii) Legal action against the <u>infamous Bill & Melinda Gates Foundation'</u> which runs a criminal conspiracy in the name of charity to help vaccine and pharma mafias and blacklist their related schemes to stop them immediately.
- (iii) Legal proceedings against Bill Gates, the main accused and senior officials of the health department and ministers involved in the conspiracy under various IPC sections of 115, 307, 409, 120(B), 34 etc., who made more than 4,50,000 children crippled for life by increasing the dose of polio in an unscientific and illogical way to help the pharma mafia.
- (iv) Deliberate Issuance of false reports by the World Health Organization (WHO) for the benefit of Pharma companies, etc; to expose conspiracies at the international level and in India based on implicated evidence, affidavits and other available malafide evidence given by the government based on WHO's instructions, which are certainly not in the interest of the common man. To intentionally expose this conspiracy that purports to enslave and impoverish countries economically by pushing people to death only for the greater interest and benefit of the pharma and vaccine mafia and carefully scrutinize the

underlying intentions of all their propositions before blindly accepting their claims without thorough investigation.

- (v) For providing unsystematic, illegal and illogical solutions to benefit thousands of crores to pharma/vaccine companies by 'suspect' officers during the corona pandemic and imposing unholy and preposterous rules upon the public causing innumerable deaths and maiming people for life due to the undeclared side effects of a trial medication. To book the guilty officers responsible for causing huge irreparable economic losses to the mass population in the country; In view of this the CBI has ordered to dismiss those guilty ministers and the ED from service immediately and register cases (FIRs) under IPC sections 166, 167, 109, 115, 302, 304, 409, 120 (B), 34 etc.
- (vi) By providing an interim compensation as practiced internationally, an amount of Rs. 2 crore per person and Rs. 25 crore per person to the deceased families suffering serious side effects of the covid vaccine and later filing a case against them in the court for more compensation from pharma companies by setting up a special 'tribunal' to get full compensation.

- 1. First Case:- One unauthorized trial of HPV Vaccine causing death of 8 innocent baby girls as per the Parliamentary Committee of 72nd Report and Honourable Supreme Court Order:-

**1.2.** But a criminal legal action is still pending on the infamous organization **'Bill and Melinda Gates Foundation'** pretending to be a charity and also against conspiracy leaders of the HPV vaccine created to benefit the guilty officers and vaccine manufacturing companies responsible for the death of 8 innocent baby girls.

**1.3.** This question is in the mind of every citizen of this country that even after 14 years of the clear instructions of the parliamentary committee on the death of the 8 girls, the CBI has still not filed an FIR against these culprits. It raises doubts that there is a lack of political will to take action against the mafia's responsible for the death o these poor girls of our country and that our system is steeped in corruption. and the corrupt officers and government officials are engaged in selling the country by becoming puppets in the hands of pharma mafia only for their own vested interests.

**1.4**. The shameful thing is that the Rajasthan government had purchased 50 lakhs of the same HPV vaccine dose and announced to vaccinate baby girls. The misuse of such huge funds and criminal intentions of such corrupt officers and the scrupulous vaccine manufacturing companies need to be thoroughly investigated and inspected by the CBI and harshest action needs to be imposed on these.

2. <u>Second Case</u>:- Another shameful incident is that by following the unscientific and unnecessary propositions of Pharma and Vaccine Mafia in India of increasing the number of polio doses by using children as 'guinea pigs' and giving them additional doses of polio vaccine, approximately 4.5 lakh children were made handicapped for life and later after protests by honest activists the criminal project was closed. It should be on record that the sole beneficiary of this entire operation of polio vaccines creator is CEO Adar Poonawala of the Serum Institute, Pune.

- **2.1.** But the government neither apologized for that wrong decision, nor gave any compensation to those victimized children and their families, nor any legal action was taken against this **'vaccine mafia'** or the then ministers and officers involved in this catastrophic conspiracy.
- 2.2. Besides there is a clear provision in the law that in such cases, FIR will be immediately lodged against such culprits and the aggrieved children and their families should be given immediate and due compensation by the government and later that amount should be recovered by the guilty officers, the manufacturer of the vaccine Institute and its CEO Adar Poonawala and all due compensations should be recovered from the main accused. - 2.3. There is also a provision in the law that any person, officer, judge or responsible authority etc., delaying action or not taking action to save the accused in any crime should be punished under Section 201, 202, 218, 219 of the Indian Penal Code (IPC), 409 and can be punished under other sections too. Nagendra Nath, (1985) 1 Crimes 446 (Ori.), Hurdut Surma, (1967) 8 WR (Cr.) 68, Narapareddi Seshareddi , In Re, AIR 1938 Mad 595, Rakesh Kumar Chhabra Vs. State of HP, 2012 CrLJ 354(HP), Moti Ram Vs. Emperor, AIR 1925 Lah 461, Maulud Ahmad Vs. State of UP,(1964) 2 CrLJ 71 (SC), Girdhari Lal,(1886) 8 All 633.]
- **2.4.** But no action has been taken in this matter as well. This is a matter of great concern.
- 3. <u>Third case</u>:- Refusing to pay compensation for deaths caused due to the covid vaccine and refusing to take action against the culprits.
- **3.1.** The Central Government in its reply given in the Rajya Sabha and in its affidavits submitted everywhere by the Supreme Court made it clear in its judgment that taking or not to taking the vaccine is the personal right of every individual and no person can

be vaccinated forcefully against his will and the unvaccinated cannot be deprived of any kind of facilities.

**3.2.** Taking cognizance of such wrongful impositions of the Central Government and citing the constitutional provisions, Hon.Gauhati High Court quashed the illegal order forcing the Assam government to make the vaccine mandatory. - 3.3. This order of the High Court was binding on the whole country as it contained Articles 21, 14, 19 of the Constitution that was incorporated. [Nabin Chandra Bachubhai Doshi vs State of Assam, 2017 SCC Online Gau 614, Kusum Ingots & Alloys Ltd. v. Union of India, (2004) 6 SCC 254]
- **3.4.** But the Central Government did not issue any guideline declarations to the State Governments or other departments regarding that particular order to abide by those rules. Contrary to that, the Center Health Ministry Secretary, Rajesh Bhushan kept insisting on 100% vaccination in his every letter.

- **3.5.** Apart from this, when many states and institutions made coercive rules for the people to take vaccines and when the aggrieved citizens raised issues, even then the central government officials refused to pay heed or discharge their duties and did not provide any relief thus leaving the public to fend for themselves.
- **3.6.** When the aggrieved citizen's petitions were filed in the Hon.Supreme Court, a demand was made to dismiss the petition inorder to support the illegal restrictions imposed by the states on behalf of the Central Government yet the Hon. Supreme Court rejected the objections of the Centre, and gave a decision in favor of the citizens, ie. Hon Supreme Court Certified the orders of the Gauhati and Meghalaya High Courts. - **3.7.** Strictest action is necessary against dereliction of duty of these guilty officers involved in such illegal activities.
- 3.8. According to the rules made by Yuno Universal Declaration on Human Rights & Bioethics 2005, the provisions of the case Montgomery Vs. Lanarkshire Health Board [2015] UKSC 11, Master Haridan Kumar Vs. UOI 2019 SCC online Del 11929, the Court orders and instructions regarding Covid-19 Vaccination Guidelines issued by the Central Government made a clear provision in this that it is mandatory to inform every person about all the adverse effects of the vaccine before taking the vaccine.

3.9. The central government has accepted the fact that many people and children have died because of the Corona vaccine (Covishield, Covaxin). [AEFI Committee Reports]

**3.12.** But in India despite of innumerable deaths having occurred due to the vaccine, neither was any ban imposed on Covishield and other vaccines, nor any advertisement published in newspapers nor broadcasted on TV channels clearly informing the citizens about its deadly side effects.

- **3.13.** With the Government machinery lying by calling the vaccine safe and by pressurizing people through illegal restrictions like linking local train travel, air travel, their salary, ration etc. with proof of vaccination, it is clear that the common man was forced to take the vaccine with harmful side effects.

In such a situation, using legal provisions, criminal proceedings must necessarily be brought against guilty officials and ministers. - 4. A loss of thousands of crores for the country by providing vaccine companies with inappropriate gains and responsibility for the death of many.

- **4.2.** Experts had clarified that it would be foolish to vaccinate people with natural immunity and this has three disadvantages :-
- (i) This will cause a burden of thousands of crores of rupees to the country;

- 4.3. This point and all research papers and proofs have been submitted by Mr. FirozMithiborwala to state and central governments under writ petition WP No. 84 of2021 in the Bombay High Court
- **4.4**. The World Health Organization (WHO) itself has clarified that both those who take the vaccine as well as those who have contracted Covid-19 once are both safe. **5.5**. In a recently published research, it was found that less than 6% of the population in Africa is vaccinated, yet the incidence of corona has almost disappreared. - **5.6.** For promoting this thought amongst citizens and spreading false narratives, it is the responsibility of the government and courts to take action against these officers and ministers.

- 7. Citizens of this country who trusted and relied on the Government's narrative on the Covid Vaccine's safety and efficacy and taking the vaccine, now having to deal with the adverse effects of the vaccines and being denied compensation is betrayal of the trust of the citizens of this country.
  - 7.1. The Citizens of this country were repeatedly subject to advertisements and bombardment from various mainstream media sources, TV, newspapers, mobile caller tunes, radio, and televised Q&A by Dr. Randeep Guleria of AIMS, National Televised appearances of the Prime Minister himself and even Justice Dhananjay Chandrachud, exhorting, encouraging, and influencing people to take the Covid vaccines repeatedly.

Reposing faith in the leaders and influencers of the country and trusting their narrative, crores of people faced undue pressure from various sources and

- were compelled to take the Covid vaccine. About 200 crore vaccinations took place in India since its launch.
- 7.2. However, the side effects of this vaccine started becoming public knowledge and the death of a young man in Norway due to side effects of AstraZeneca Covishield vaccine, resulted in 21 countries banning the use of the Covishield. - 7.3. However, no such restriction was imposed in India. On the contrary, several illegal and unconstitutional restrictions were imposed to force one to take the deadly vaccines.
- 7.4. The surprising fact is that for approving Covishield vaccine in India, the Government of India relied on the Phase II & III trials of Covishield conducted in 'Britain (UK)', for granting Emergency Use Authorization was given in India. The Central Government has made this submission in its affidavit filed by the matter of <u>Jacob Puliyel Vs. Union of India 2021 SCC OnLine SC</u> 533.

- 7.5. It is apparent that when 21 countries of Europe and some other countries banned Covishield vaccine due to its fatal side effects, the people of India were pushed to their death by not only failing to impose any restrictions by the Health Ministry of India and the Health Ministry and vaccine related departments, but by also withholding this information from the public. By such an action and failure to act in conscience by the government of India, it is bound to provide compensation to all the citizens for the side effects caused by the vaccine. The Supreme Court has also made a clear law regarding this in the matter of

The Japanese government on the other hand in an exemplary act of transparency and honesty, warned all their citizens about the side effects of the Covid vaccines and established a special 'Human Rights Department' to act against the officials and companies who forced the people to take the Covid vaccine and appealed to the citizens about using the newly created department to file such complaints of coercion.

It is necessary to investigate who and which entities were responsible for obstructing the decision to protect the life and interest of Indian citizens by failing to publish the advertisements like the way it was done in Japan and/or from banning the Covishield vaccine like 21 European countries did.
- 7.8. The Singapore Health Ministry awarded a compensation of Rs. 1 crore 78 lakh to the family of the child that suffered a heart attack from Pfizer Covid-19 vaccines without them making any application, as due to increase in heartbeat a side effect of the corona vaccine.

- 7.12. In Britain (UK), the citizens there have filed about 920 cases in the court demanding compensation for the adverse effects of the vaccine.
- 7.13. The Thailand government has given an amount of \$ 1.71 billion (about more than 400 crores) to about 14,034 people suffering for the side effects of the Covid vaccine and to 3670 families for the death of their family members due to the Covid vaccine.

7.15. The World Health Organization also announced compensation to the citizens of the world who have suffered side effects from the Covid vaccines and announced the last date for submitting the application, with the condition that

the citizens would not file a cases against the vaccine companies if the World Health Organization provided the compensation.

- 7.16. The citizens of India did not apply to the World Health Organization because they believed that the leaders and officials of their country would give them due compensation or help them get the maximum compensation from the guilty vaccine companies and from the guilty authorities.
- 7.17. However, Dr. Veena Dhawan, Under Secretary of Department of Immunization, Ministry of Health and Family Welfare, Central Government of India, in the affidavit filed in response to the petition of Rachna Gangu in the Supreme Court on 23 November 2022, has claimed no responsibility of the government and has advised the victim's family to file a case against the guilty officials and vaccine companies in the local courts, thereby showing their reluctance and shying away from the whole matter.

- 7.18. In that affidavit, it was amply clear that the government had promoted a lie that they had already informed all the citizens and made known about all the fatal side effects of the Covid vaccine and that no pressure was being imposed by the Government on the citizens to take the vaccine or any or restrictions were being imposed on those who did not take the vaccine. Hence, If in knowledge of the side effects of the vaccine, if the citizens takes the vaccine, then the citizens are themselves to blame and the government cannot be held liable.
- 7.19. This affidavit reveals the falsehood of the Government's narrative and it is amply clear from the above evidences that neither did the government inform the public about the side effects of the vaccine, nor was the "Vaccination" voluntary. Instead, the government repeatedly lied to the people that the vaccine is completely safe and that the citizens should not pay attention to rumors being circulated. Citizens who did not take the vaccine were indirectly compelled by debarring them from travelling by public transports such as train, airplane and entering many public spaces.
  - "Ghar Ghar Dastak" campaign revealed many cases where the Government attempted to access people's homes and forcibly vaccinate them.
- 7.20. This clearly reveals that the Government's two-fold agenda of deceiving the people of the country and the Supreme Court by submitting false affidavits/statements and by misusing the government machinery to shelter the main accused individuals and to mislead the judiciary. Under the provisions of the law such criminal acts should be prosecuted under IPC 191, 192, 193, 199,

200, 201, 218, 409, 471, 474, 120(B), 34 of IPC for which punishment range from 6 months to life imprisonment for the guilty.

Strict legal action is necessary and exemplary against the guilty officers and the minister of the department, and they should be dismissed from their posts immediately.

- 8. The World Health Organization (WHO) officials and Bill Gates have conspired to and unsuccessfully attempted to create epidemics of 'monkeypox' and "swine flu" so as to give undue advantage and benefit to vaccine companies, this is sufficient evidence to make them culpable and guilty of being awarded the death sentence.
  - 8.1. The World Health Organization (WHO) receives donations from various vaccines and pharmaceutical companies. Its biggest donor is the "Bill and Melinda Gates Foundation"
  - 8.2. Bill Gates has partnerships with many vaccine companies and to provide undue benefit to these companies, he donates to different programs that create research papers that support his false narratives and conspiracies to move public opinion in the direction of these false narratives, leading people and governments to people believe these lies, preventing vaccine bans and their inclusion in the country's national program and thereby accruing automatic profits for the Vaccines companies. This modus operandi has been revealed in the 72nd report of the Parliamentary Committee.
  - 8.3. It has been evidenced that the WHO acts only to further the goals of the Pharma mafia that engages with such criminal mindset.
  - 8.4. Hence, it is not a secret that most of WHO's suggestions are only aimed with the sole purpose of providing undue benefits and advantage to pharma companies.
  - **8.5.** The Indian Government has many times in the past called out the lies of WHO's recommendations/proposals and has on the contrary adopted measures that were scientifically valid.
    - (a) The Government of Goa, in an affidavit filed in the High Court, rejected WHO's suggestion of Ivermectin's ineffectiveness against Covid-19 and termed it as flawed and incorrect and instead recommended Ivermectin to all its citizens.

8.9. All this provides clear evidence of the years of prior planning and the modus operandi of the conspiracy being hatched by the leader of the pharma industrial complex Bill Gates and the corrupt machinery of the WHO to force people to take the deadly vaccines by instilling fear of new epidemics. - 12. We humbly request you to register an FIR immediately in this grievous matter with the CBI, ED, Income Tax Department, RAW etc.

- 15. We sincerely hope, you consider the lives of the citizens of the country more valuable than the profits of the vaccine mafia.

#### 16. We request you to pass the following orders immediately: -

- (i)Prosecution of persons/officers culpable of death of 8 minor girls as per the 72nd Report of the Parliamentary Committee and for their role in delaying prosecution of accused culprits and Pharma Mafia under IPC 218, 201,302, 304, 409,120(B), 34 etc.
- (ii)To initiate legal action against the infamous 'Bill & Melinda Gates Foundation', which runs a criminal conspiracy under the guise of charity to help vaccine and pharma mafias, and to seek immediate closure of their related schemes and operations by blacklisting them through legal and court approved sanctions.
