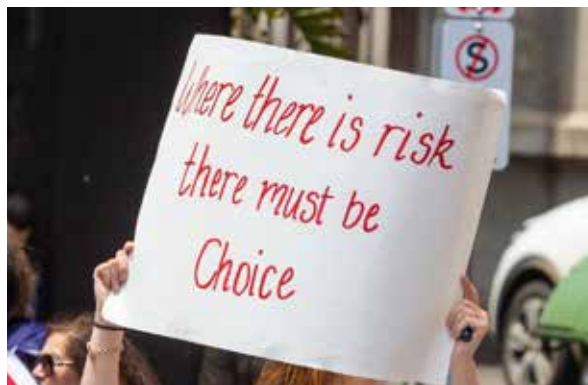

LEGAL CASES



Karnataka High Court- Any pathy allowed to cure Corona

A landmark judgement was given by Karnataka High Chief Justice Abhay Oak declaring that choice of treatment is a fundamental right of all citizens. After this order the government had to allow all pathies to treat Covid 19 and also the AYUSH protocol was released.



Only allopathy was being used for covid treatment. Some Ayurvedic doctors filed a case in Kerala high court, which was rejected and a 1 lakh rupee fine was imposed on them by the court. After this incident, AIM filed an RTI questioning the government on why traditional medical systems like Ayurveda/ Homeopathy/ Unani/ Naturopathy etc. were not being allowed for treatment of Covid-19 disease. The reply came from MoHFW that Covid-19 is a new disease hence only modern medicines are to be used. AIM was appalled at this reply because life threatening drugs which are banned in several countries like Remdesivir, Favipiravir etc. were being used for Covid treatment. AIM challenged this in Karnataka High Court through Human Rights Law Network (HRLN) Advocate Colin Gonsalves.

Jacob Puliye Case



Jacob Puliye a member of the National Technical Advisory Group on Immunization (NTAGI), an already awakened person to the sham of Covid-19, became a torch bearer and history was made when AIM members requested him to be the petitioner and a herculean effort was put forth to file a PIL where the petitioner asked to disclose the trial data for vaccines, rationale behind the Emergency Use Authorization (EUA) of Covid-19 vaccines, post vaccination data regarding Adverse Events of Covid vaccines, and urged to declare vaccine mandates in any manner to access any service or benefits, to be a violation of the fundamental rights of the citizens.

After the detailed arguments by Advocate Prashant Bhushan for the Petitioner, the Center, States, the vaccines companies, the verdict in the Jacob Puliye Case in the Supreme Court is of paramount importance where the Supreme Court declared all vaccine mandates as disproportionate and deduced that the vaccinated or the unvaccinated individuals presently appear to be susceptible to transmission of the virus at similar levels. It concluded that all Institutions and Organizations whether public, private or educational have to recall all the restrictions on the unvaccinated. It also ordered to facilitate recording Adverse Events following Immunization (AEFI) through the Co-win portal which is a cardinal directive in the history of India.

The verdict in the Jacob Puliye Case in the Supreme Court concluded that all Institutions and Organizations whether public, private or educational have to recall all the restrictions on the unvaccinated, transmission of the virus at similar levels.

The mandates brought in the State of Maharashtra gave the impetus to file the petitions regarding the arbitrary orders of the Chief Secretary discriminating between the vaccinated and unvaccinated, and denying to the unvaccinated access to public facilities and services like the Railways, Malls, Schools and College Campuses etc. The SOPs/Orders issued by the Chief Secretary were of serious nature because of which many people have lost lives as vaccine was a prerequisite to travel by Mumbai Local trains.

The IBA with its legal knowledge and AIM with its scientific acumen compiled a petition to challenge the SOPs and exposed the fraud of the State of Maharashtra and its highest officers. Subsequently all the orders were declared to be illegal and abrogative of the fundamental rights.

Adv Nilesh Ojha made AIMs missions his own and got on the fight with full gusto and has since been famous throughout the country. The synergy and enthusiasm was evident as both AIM and IBA went on working on the Petitions, Notices and letters. Without taking a break both of them have been tirelessly working to take on the vaccine mafia, corrupt bureaucrats and politicians which have been creating havoc in the lives of Indian citizens by imposing unscientific, illegal, illogical mandates and perpetrating scams worth billions of dollars under the name of Covid plandemic.



Pankaja Sen Assam



Pankaja Sen's family was forcibly vaccinated in front of the DM and Superintendent of Police in Assam on the orders of the DM. Pankaj Sen approached AIM and AIM filed a case of contempt of Gauhati High Court which had already passed an order that vaccines cannot be forced on anyone and it is voluntary and vaccinated people are also super-spreaders of Covid-19. One more petition of Pankaja Sen was filed in Supreme Court of India.

AIM Member Jagadish Chanda has filed a PIL against illegal, illogical, unscientific mask mandates

Dilip Lunawat, Bombay High Court

- The Government of India's AEFI (Adverse Event Following Immunisation) Committee has recently admitted that the death of another deceased Dr. Snehal Lunawat, was due to side effects of the Covishield vaccine. [copy of AEFI certificate is annexed to the petition] The said report has exposed the falsity of the claim made by the vaccine syndicate that vaccines are totally safe.
- Plaintiff has claimed Rs. 1000 crores (\$ 134 million USD) compensation and has asked for interim compensation of Rs. 100 crores (\$ 13.4 million USD).
- Plaintiff has also sought Lie Detector, Narco Analysis Test of accused Bill Gates and others.
- Petitioner has also referred to the proofs of the sinister plan of Bill Gates in the polio vaccination programme which spoiled the lives of more than 4.5 Lakh children in India as they suffered a new type of paralysis. This is also an additional proof of Bill Gates' perverted and criminal mindset.
- The Plaintiff also relied upon the criminal antecedents of Bill Gates in killing 8 female children by unauthorized trial of HPV vaccines in India.



Rachana Gangu, Supreme Court of India

Hitesh Kadwe, Bombay High Court



- In what may be the first legal case of its kind globally, a petitioner in India is seeking to prosecute Bill Gates, Indian vaccine czar Adar Poonawalla, and Indian government and public health officials over the death of a 23-year-old man who died after receiving AstraZeneca's Covishield vaccine.
- Kiran Yadav late last year filed a criminal writ petition for murder, Smt. Kiran Yadav v. The State of Maharashtra & Ors., with the Bombay High Court of Judicature, on behalf of her deceased son, Shri Hitesh Kadwe.
- Her son was vaccinated on Sept. 29, 2021. According to the complaint, he died that same day due to side effects brought on by the vaccine.
- This case has got more widespread attention in the US media than it has in India.



Riddhi Arora, Supreme Court of India



Despite no Safety trials conducted on Covid vaccines for Pregnant Women, the Government of India started vaccinating pregnant women and lactating mothers with the Covid Vaccine. A PIL was filed in the Hon'ble Supreme Court of India to ensure active surveillance and maintain a transparent record of Adverse Events Following Immunization. 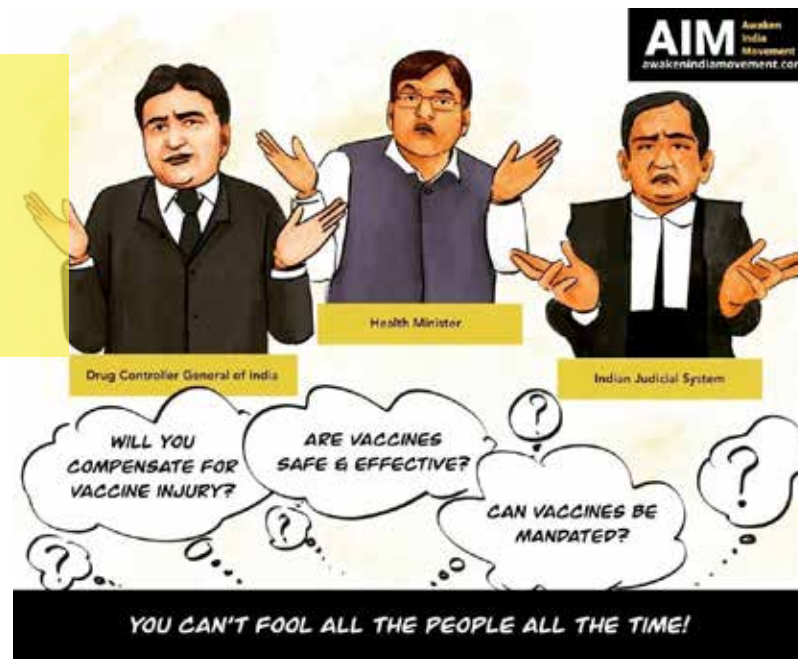

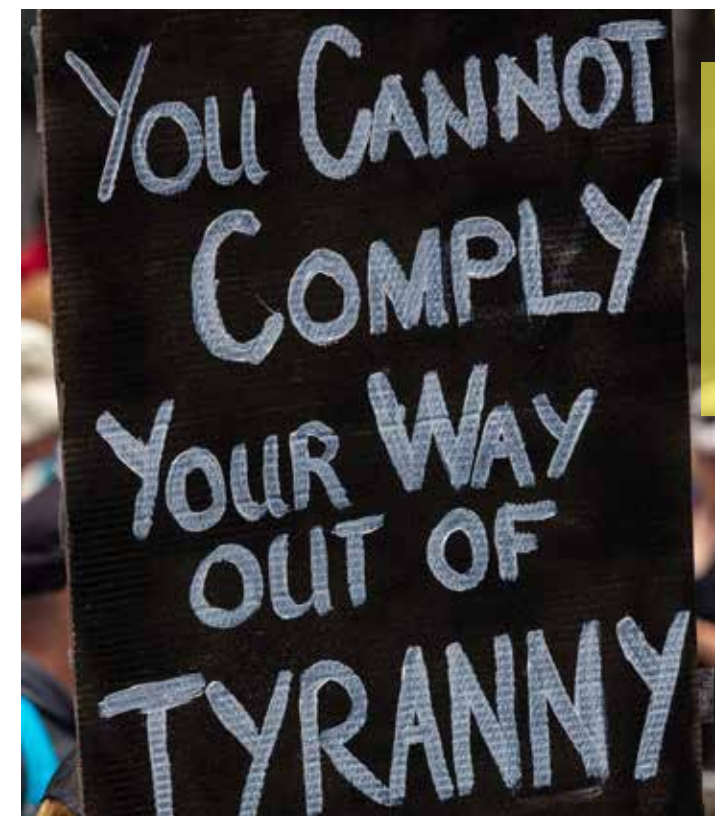


Ambar Koiri, Mulund Magistrate Court

3. Petition to improve and make functional, AEFI Reporting and it's active Monitoring in India.

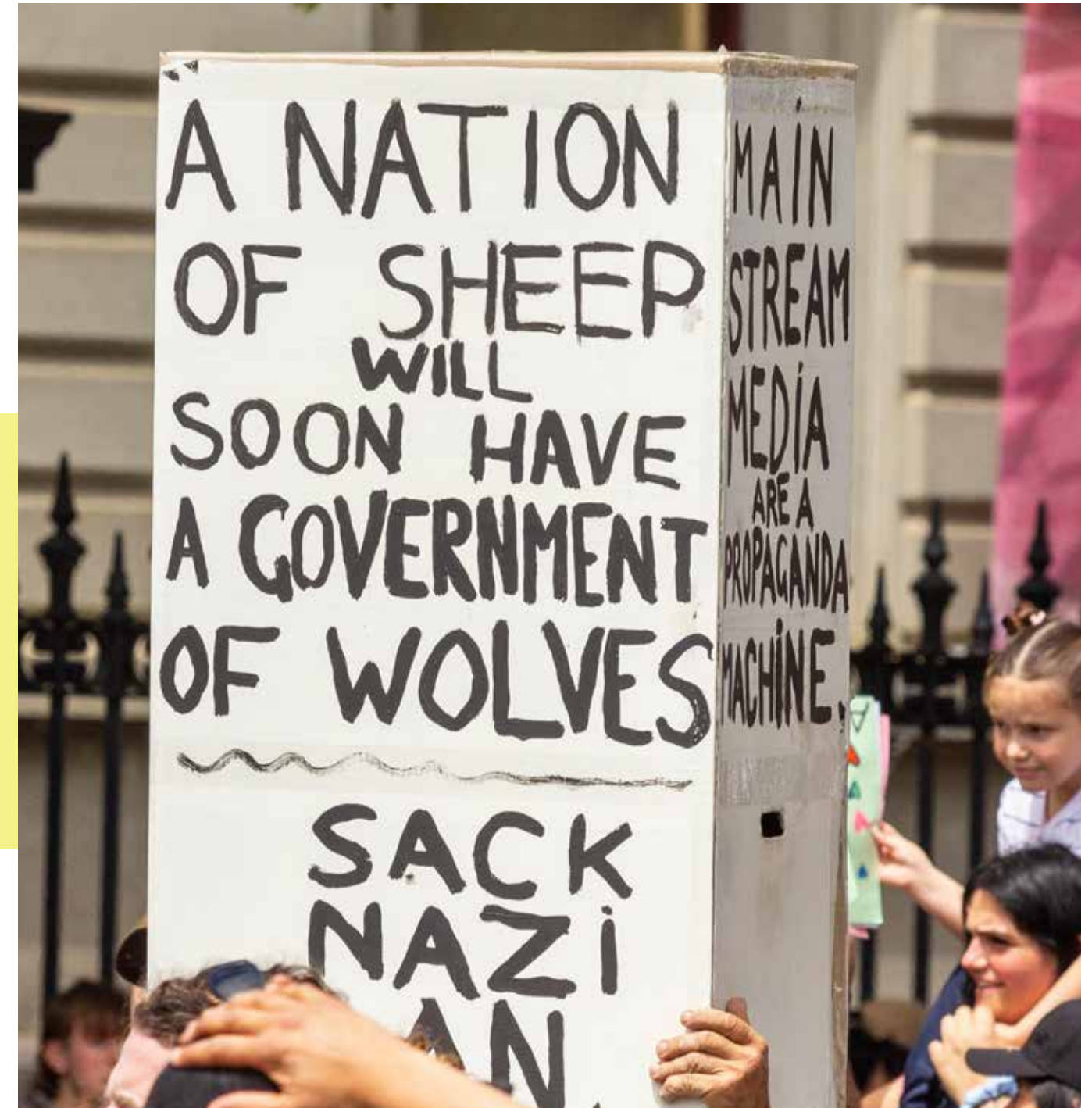
Letter to Health Minister Public Health Bill

Medical Exemption Certificate RTI

COVID-19 Vaccine Administration Cell (CVAC) has clearly indicated the following on 02.Aug.2021 in their response to RTI MOHFW/R/E/21/04552: "If anyone is concerned for any specific health reason before COVID Vaccination, please consult a doctor/Health Care Provider.

It is duly advised, advertised and communicated by MoHFW through various print and social media platforms that all citizens should get vaccinated, but this in no way implies that any person can be forced to be vaccinated against her/his wishes. Covid Vaccination is voluntary."

Furthermore, as per the factsheets of the approved Covid vaccines in India, there are certain categories of individuals who should not be administered any

Covid vaccine. Awaken India Movement in association with Indian Bar Association have drafted the Exemption Certificate in order to help anyone who is coerced into taking the experimental Covid vaccine. You may submit this to your educational Institutions, Employers or Government authorities.

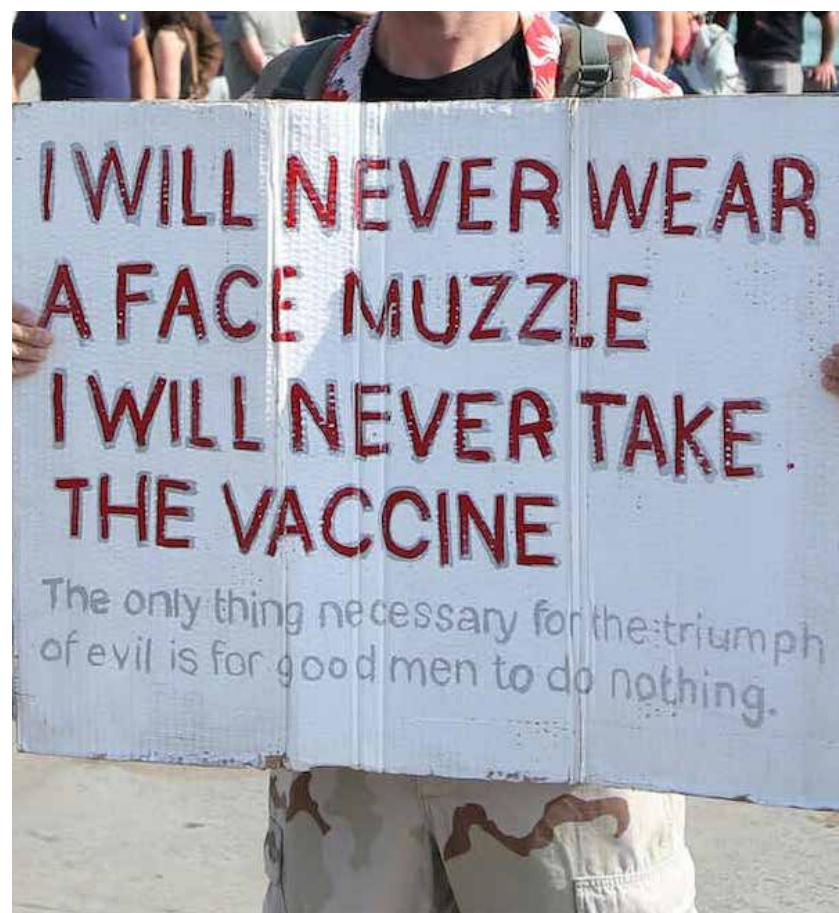

Is a vaccine even needed for COVID: Citizens' group asks

Citizens' movement group Awaken India questions the authenticity of the vaccines under trial and says that they shouldn't be made mandatory

EVEN as the nation waits for a COVID-19 vaccine with bated breath, the recently formed citizens' movement group, Awaken India, put forward a question — Is a vaccine even required for COVID-19? — at a press meet held at the Marathi Patrakar in CSMT on Friday afternoon. Various speakers, including students, activists and lawyers spoke on the topic and highlighted aspects like faulty RT-PCR tests, herd immunity, legal accountability and after effects of vaccine trials.

Questions unanswered

The group has been carrying out an anti-mask campaign for the past several months and also believes that the vaccine should not be made compulsory for people. "Questionable data, faulty tests and media hype have led to people across the

world waiting desperately for a COVID-19 vaccine," said the group. "Amid the desperation and pharma company proclamations, many key questions remain unanswered," it added. Speakers at the event included noted activist Feroze Mithiborwala, Nammam Bhasin, Ambar Koiri and Bhavya Dhawan, who are members of Awaken India.

Speaking to mid-day, Mithiborwala said, "On one hand we are saying that the COVID-19 numbers are dropping but on the other we are rolling out vaccines whose side-effects are not yet fully known. Even if a vaccine has to be rolled out, why make it mandatory? It will do more harm than good." Feroze Mithiborwala, activist

vaccines whose side-effects are not yet fully known. Even if it (the vaccine) has to be rolled out, why make it mandatory? I believe it will do more harm than good." He added, "This was never a pandemic. A sense of fear psychosis has been created over the past eight to nine

months by saying that cases have been constantly rising. The RT-PCR tests are fraudulent and can be easily manipulated." "Public health and safety require utmost caution and informed consent of citizens. I don't understand why we're talking about every single per-

son being coerced into taking an experimental vaccine that has been produced in just a couple of months. If the vaccines being produced do not guarantee that people won't get COVID or its spread can be stopped, then what is the point of taking it?" said Bhasin.

Herd immunity

The discussion also focused on herd immunity, lack of legal liability and accountability of pharma companies with regards to vaccines and previ-

ous vaccine scandals in India. "Nationwide Serological Surveys show that 50 per cent of the population has developed antibodies. Hence, as a nation, we have already achieved herd immunity," said the group in its press statement.

A PowerPoint presentation spoke about how pharma companies own many doctors, researchers, academic institutions and how many so-called reports or evidence that are relied upon are written and reinforced by individuals who have financial ties with the firms. According to the group, media and social networks also played a vital role in ensuring that the above-mentioned information was constantly suppressed, discredited or hidden from the public eye. The group added, "We live in information bubbles and cannot easily see what is happening in other countries. People should go through this with an open mind."

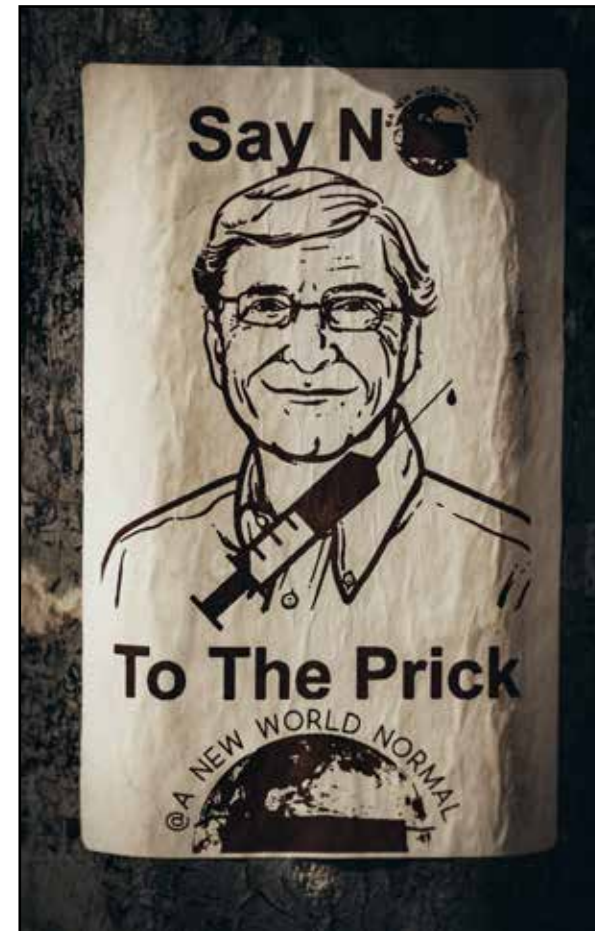
