SAY NO TO CBDC / E RUPEE: Central Bank Digital Currency

Our government says printing currency uses a lot of precious money which could be otherwise used for better purposes like taking care of the poor etc. Even earlier they were hinting that we should be going towards a cashless society. And therefore they say we need to go for the CBDC or a Central Bank Digital Currency. Thus, every transaction that you make will become known to the RBI and to the Central Government.

Now, let us say, you are giving a donation to a particular organization that is protesting against the government policies, then that transaction could be blocked easily. Or if you are seen to be opposing the government's policies, again your money could be made dis-functional. How Can they do this? Because **this currency is a programmable currency**. Therefore, they can easily program the currency on matters like where all it can be used and for what purposes it can be used etc, using Al and relevant software. Whereas in regular digital payments YOU decide about who to pay and what to pay for etc, in case of the CBDC, the Government decides where and on what you can spend your money on.

Now that the government controls your money, it becomes very easy to control YOU. Thus, they can decide if you will have a right to protest against a certain policy or not. So, from being a democracy of for the people, by the people, of the people, we will become a totalitarian system.
