Dear Sir/Madam,

We enclose the Citizens' Sign-on dated 14th May 2024 to the Director General (DG) of the WHO, informing the WHO that we advise our Government that India must EXIT the WHO. There are four outstanding reasons for our action as annunciated in the letter, which briefly are:

(i) Even as we write this, respected Prime Minister, the clauses of the inextricably interlinked documents of the 'Treaty' and the Amendments to the International Health Regulations, (IHR) are still being subjected to change. Therefore, it is indeed curious that a process of submission is still being finalised and in secret by the WHO, when the public is still in the dark about the clauses to be agreed upon. They are not in the public domain (ii) Through the clauses of both the above linked documents, the WHO seeks for itself, a world-wide Health 'Dictatorship Role' through its Director General (DG). This is an unelected, unaccountable Body under the Constitution of India, --- unelected by the Citizens of our Country and every democratic Nation State that is a Member of the WHO

(iii) This undemocratic, dangerous and misconceived objective is buttressed by "binding clauses" in both the 'Treaty' and the IHR, to enforce such a dictatorship. These Clauses are Ultra Vires the Indian Constitution and therefore, illegal.

(iv) In the past, the WHO was subservient to sovereign clauses and the sovereignty of every Nation State. Not today. The WHO has a massive, deep –rooted irreconcilable conflict of interest. Its funding derives mainly from a combination of Corporate Power (Bill Gates, the largest funder) and the Biopharmaceutical Complex (BC), from which it also derives its revenue streams. This means that the WHO is driven by these entities; it does their bidding for their objectives, their strategies and their profit motives, instead of the public interest. For this reason alone, the WHO may not be trusted. We request our Government to therefore, exit the WHO altogether.

We send this email to you with the certainty that you are fully in agreement that both the 'Treaty' and the Amendments to the IHR are unconstitutional.
